However, translated notarised copy of the same has been uploaded by school on its website under Icon "About Us > Mandatory disclosure section". 5. The school is directed not to remove any documents from its website including the certificate mentioned at Sl. 2, 3 & 4 and the videography link of the inspection day in future. 6. The school has uploaded the videography link, while viewing of the same it has been observed that in some portion, height of the Boundary wall is not maintained as per the Board's norm. Therefore, the school is directed to ensure Boundary walls to be erected with minimum 6 Feet height and upload the videography of the same on the school website before making school operational. 7. As reported by IC member, dimension of all labs and library filled by school are incorrect.
