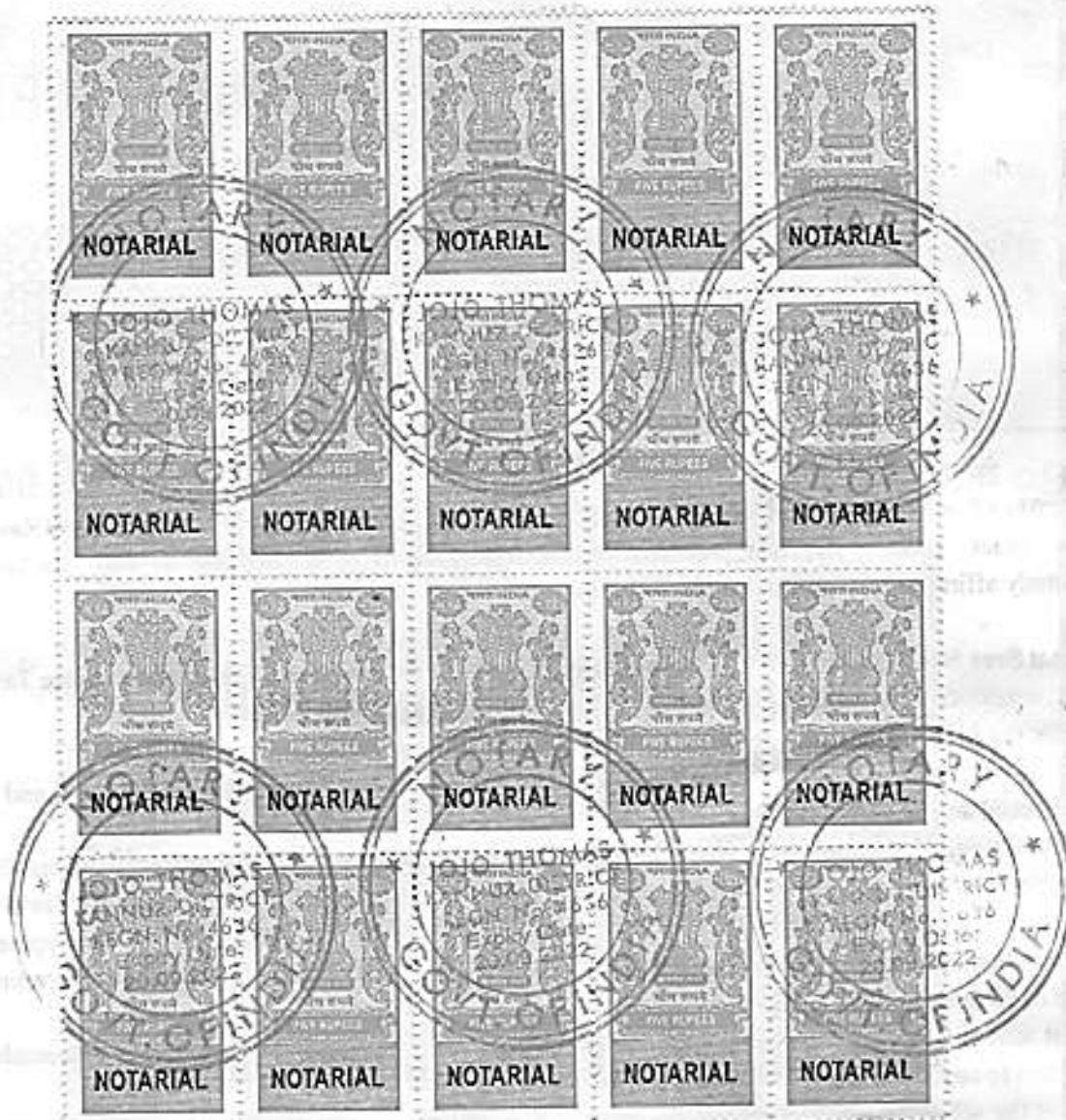

7.
